- Location:** Western Reserve Bank, 4015 Medina Rd., Medina, Ohio 44256  
(At Rt. 18 and Foote Roads)
- Eligibility:** All members of the Medina County Art League.
- Eligible Work:** Only two dimensional works, oil, watercolor, acrylic or pastel paintings, drawings, inks, photography
- Size of work will be worked out with the individual artists, as will the number of pieces per show
- Work should be professional in appearance in as far as the framing and matting are concerned and **ready to hang with WIRE.**  
**No saw tooth hangers.**
- Sales:** No commissions. Artwork may be sold through the artist, BUT must stay in the show for the entire 2-month period of the show. We will have a catalog for each show stating artist name with bio or artist statement and phone number, a list of artwork, (titles, size and medium), and price, (all information will be provided by the artist). The catalog will be available at the bank for anyone wishing to contact the artist.
- Publicity:** Each artist is responsible for any publicity he or she wants to have, with the approval of the committee.
- Liability:** Medina County Art League and Western Reserve Bank accepts no liability for damage or loss to slides or photos or artwork no matter the cost. We will be careful to protect artwork, but again we assume no responsibility.
- Fee:** : There is a \$10 hanging fee due at the time the paintings are delivered to the bank, checks should be made out to Medina County Art League.
